CRITERIA FOR AFMA MEMBERSHIP

ACTS OF FAITH MINISTRIES ASSOCIATION UPHOLDS HIGH STANDARDS OF SERVICE AND WITNESS AND ALWAYS REFERS TO THE BIBLE AS 'THE STANDARD BARER'. CANDIDATES FOR MEMBERSHIP OF AFMA MUST ALSO BE IN AGREEMENT WITH THIS. THEREFORE, THE CRITERIA SET FORTH MUST BE ADHERED TO IN ORDER FOR AFMA TO CONTINUE A HEALTHY AND PROSPEROUS RELATIONSHIP WITH MEMBERS.

1. THE MEMBERS MUST BE WILLING TO BE RESPONSIBLE AND ACCOUNTABLE TO AFMA AND TO ABIDE IN THE RULES AND REGULATIONS OF AFMA. HOWEVER, AFMA WILL NOT INTERFERE IN THE WAY THAT THE MEMBERS' CHURCHES FUNCTION.
2. MEMBERS MUST REPRESENT A RECOGNISED CONGREGATIONAL CHURCH (INDIVIDUALS ARE NOT INCLUDED).
3. FINANCIAL COMMITMENT - MEMBERS TO PAY AN ANNUAL SUBSCRIPTION.
4. REGULAR ATTENDANCE TO MEETINGS. TO BE UNITED AND COMMITTED WITH THE VISION OF AFMA, MEMBERS MAY BE ASKED TO ATTEND AT LEAST 2 MEETINGS A YEAR.
5. MINISTERS CHURCHES VISITED IN ORDER TO BUILD RELATIONSHIPS AND FOR AFMA TO GET TO KNOW THE CHURCH.
6. CHURCHES TO PASS AN INITIAL ASSESSMENT.
7. WE RESERVE THE RIGHT TO REVOKE MINISTERS LICENCES AND CHURCH MEMBERSHIP OR REFUSE APPLICANTS ENTRY INTO AFMA SHOULD THE MEMBERSHIP CRITERIA NOT BE MET OR UPHELD.
8. CHRISTIANS MUST ACCEPT THE REVELATION OF THE TRIUNE GOD GIVEN IN THE SCRIPTURES OF THE OLD AND NEW TESTAMENTS AND CONFESS THE HISTORIC FAITH OF THE GOSPEL THEREIN SET FORTH.
9. NO DECISION ON BEHALF OF AFMA CAN BE MADE OR EXERCISED WITHOUT THE PRIOR NOTIFICATION AND WRITTEN APPROVAL OF AFMA.
10. ALL MINISTERS ARE EXPECTED TO UPHOLD ECCLESIASTICAL PROTOCOL.

BASIC STATEMENT OF BELIEF

THESE HERE ARE FUNDAMENTALS THAT WE REGARD AS CRUCIAL TO THE UNDERSTANDING OF THE FAITH AND WE SHOULD FOLLOW THEM IN MUTUAL LOVE AND PRACTICAL CHRISTIAN SERVICE.

THE NICENE CREED

WE BELIEVE IN ONE GOD, THE FATHER, THE ALMIGHTY, MAKER OF HEAVEN AND EARTH, OF ALL THAT IS, SEEN AND UNSEEN. WE BELIEVE IN ONE LORD, JESUS CHRIST, THE ONLY SON OF GOD, ETERNALLY BEGOTTEN OF THE FATHER, GOD FROM GOD, LIGHT FROM LIGHT, TRUE GOD FROM TRUE GOD, BEGOTTEN, NOT MADE, OF ONE BEING WITH THE FATHER. WITH THE FATHER AND THE SON HE IS WORSHIPPED AND GLORIFIED. HE HAS SPOKEN THROUGH THE PROPHETS. WE BELIEVE IN ONE HOLY UNIVERSAL AND APOSTOLIC CHURCH. WE ACKNOWLEDGE ONE BAPTISM FOR THE FORGIVENESS OF SINS. WE LOOK FOR THE RESURRECTION OF THE DEAD, AND THE LIFE OF THE WORLD TO COME. AMEN.

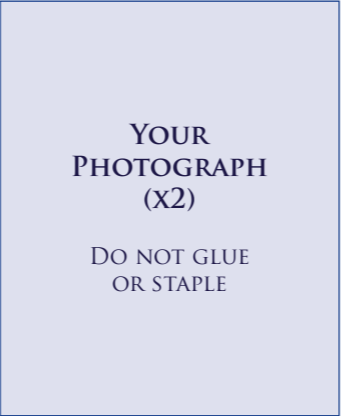
